4. I (owner) understand and agree that during normal dog play my dog(s) may sustain injuries despite the best supervision. I agree that Canine Country Club will not be held responsible for any injuries to my dog(s) during attendance, and I release Canine Country Club from any liability whatsoever, provided all reasonable care and precautions are followed (see general policies). _____ (initials)

5. I (owner) further understand and agree that in admitting my pet(s) to Canine Country Club, CCC has relied on my representations of my pets' health and temperament. _____ (initials)
